Event Information

Grad Nite dates: May 17th, 23th, 31st and June 7th, 2024 --Private Event, not open the public.

Time: 8pm- 3am only. This is NOT a mix-in with general public admission for day-time operations.

NOTE: Park exit gates will be opened no earlier than 2:30am for students to freely walk to the buses.

Student Meal time*: 8pm-midnight

Student Meal location *: EAST and /or WEST Picnic Pavilion located inside Main Gate

Student Menu*: Hotdogs, Chicken Strips w/BBQ sauce, Baked Beans, Caesar Salad, Ice Cream Novelties, and Soft Drink (Subject to change), please have individuals with dietary restrictions ask the staff for the options we have for that day.

Student Package (\$115): Includes Admission ticket, All-You-Can-Eat Dinner Buffet, Digital Photo, Grad Pass (2024 season pass) and a Souvenir (this will be handed out at the park).

Chaperone Package (ticket earned for every 10 student package tickets purchased): Includes admission, Grad Pass and meal located at the Chaperone Center. **Additional Chaperone tickets/package can be purchase for \$90.

Grad Pass (2024 Season Pass) is valid from your selected Grad Nite date thru December 31st 2024, NEW—including Fright Fest, Six Flags Hurricane Harbor, Six Flags Discovery Kingdom, Hurricane Harbor Concord and Hurricane Harbor Phoenix.

Where to redeem the Grad Pass:

Season Pass Processing Center- Located across from Ticket Will Call after Security screening. (Open prior to the Entrance Gates opening at 8pm).

Guest Relations- Located in the Main Gate Area next to Six Flags Emporium (once the park opens at 8pm).

VERY IMPORTANT: the grad pass must be activated at Six Flags Magic Mountain first and then can be used at the other parks. Please arrange for the students to receive the voucher ahead of time so they have the opportunity to redeem before the end of the night.

Additional tickets (Student or Chaperone) will be available for purchased after initial payment is made prior to twenty-one (21) days before your event. We will not be able to add on tickets within twenty-one (21) days of your date. Those tickets can be purchased at Ticket Will Call the night of your visit. Card only, no checks will be accepted.

Coordinators/ Organizers

The number of tickets on your agreement is **not** the number you must purchase, if the number needs to be changed, please notify the contact at the park with advance notice for the change to be submitted and lead time for payment to be received. Final Payments are due 3 weeks prior to your event date.

Tickets are non-refundable. If you are not 100% sure on the exact number you need, purchase less and additional tickets will be available to purchase at Ticket Will Call the evening of your visit, with a credit card, for the same cost.

Note: payments are to be mailed to Six Flags Magic Mountain, PO Box 732302, Dallas, TX 75373-2302 and not the Valencia address as in past years. If payment is received after the due date, a rush fee will be applied. Please double check your systems have been updated to avoid delays in payment.

Tickets will be shipped once payment is applied, please allow a lead-time of twenty-one (21) days for shipping and delivery. Please verify your address on the agreement, this is where the tickets are shipped to.

Payments received within the twenty-one (21) day window of visit date, will incur an additional rush fee. Please plan accordingly to avoid setbacks with receiving tickets/wristbands in time.

CHAPERONES

All schools will be given one (1) complimentary chaperone wristband/tickets per ten (10) paid student wristband/tickets purchased.

Chaperone wristbands will be your ticket, which includes barcode that will be scanned upon entry. These wristbands will gain you access to the chaperone area and exit passes to rides. No student should have these wristbands.

Chaperones, just like students, must adhere to all Grad Nite rules and regulations.

The “Main Contact” from each School must check in to the chaperone center immediately following admission to Event. *(Main Contact is listed on Chaperone Contact Form which is due **one week prior to the event**. Online link will be provided at least two (2) weeks before your Grad Nite date.)*

The school is required to confirm a minimum of two (2) and a maximum of ten (10) chaperone names and contact numbers are provided and submit any changes to the list upon check in. IF you have more than ten (10) chaperones attending, please list only the ten (10) that will be available throughout the night. In the event that contact must be made with Chaperones, we request that all Chaperones listed be accessible throughout the entire event.

We are asking if any student(s) arriving late or leave earlier that they are listed on the Chaperone Form and MUST be escorted from a parent or guardian to a chaperone or vise-versa. At chaperone check in- please let the Six Flags staff know if an update is need. This would include if the entire school is departing the park prior to 2:30am.

Six Flags Magic Mountain (SFMM) will provide a chaperone center for all chaperones participating in Grad Nite. This center will be located at the **Full Throttle Sports Bar** near Full Throttle Plaza.

SFMM will use this center to communicate with all schools in case of an emergency or any other incident occurring during Grad Nite. Chaperones must wear wristbands at all times. Chaperones are responsible for all students and guests regardless of their age.

Six Flags understands that many chaperones go out of their way to help on this night. In an effort to show our appreciation, identified Chaperone areas ONLY will provide movies, meals, and refreshments at no charge.

All chaperones participating in Grad Nite must have knowledge of the rules and regulations and be aware that they are responsible for all students participating from their school.

Park Policies

In addition to the Park Policies already in place at Six Flags Magic Mountain, the following rules and regulations apply during Grad Nite:

- Absolutely **NO** Alcohol, Drugs, or Weapons of any kind are permitted.
- We are a cash-less park, reverse cash machines are available through out the park, put in cash and get a Pre-Paid Visa Card that can be used anywhere Visa is accepted.
- Six Flags is a **SMOKE-FREE** Park and will not tolerate smoking in the park at Grad Nite. If chaperones would like to smoke they must exit the park. This includes E-Cigarettes and Vaping.
- Only buses or chaperone driven vehicles will be permitted to park. Absolutely **NO** student driven vehicles will be permitted.
- No student or guest of a student will be permitted to leave Grad Nite prior to park closing, unless accompanied by a chaperone.
- In the event a student is involved in a situation, and in normal cases would be ejected from the park, the student must stay with a chaperone until the event is over or a parent/guardian has picked them up.
- ALL Vehicles attending the Grad Nite should arrive no earlier than 6:30pm.
- No outside food, drink, coolers or other food containers are permitted. Empty Hydro refillable type bottles are allowed.
- ALL students and guests are required to adhere to the Dress Code provided or entrance to Grad Nite may not be permitted.

DRESS CODE

All students must adhere to their school's dress code policies and must meet, at a minimum, Six Flags Magic Mountain's standard park dress code. We offer a suggested list of clothing/items to help prevent delays in entry. It is the school's responsibility to ensure all participants are dressed appropriately prior to arriving at Grad Nite. Anyone not adhering to the event dress code may have delayed entry into the park and may not be granted admission without finding alternate clothing.

SIX FLAGS PARK DRESS CODE

In keeping with our family-friendly environment, and for safety reasons, Six Flags enforces a dress code. Proper attire must be worn in the park at all times, including shirts and appropriate footwear. Clothing or tattoos with offensive language or graphics are not permitted at any time. WE strongly advise no School Logos are displayed on any clothing or bags.

Students will be limited to small purses or draw string bags; no backpack or duffle bags will be permitted.

Examples of clothing **NOT** permitted are those displaying:

- Profanity
- Pornography
- Graphic violence
- Support of drugs and drug use
- Gang symbols
- Promotion of discrimination against any group
- Ski Masks

Remember:

- Six Flags Security has the right to refuse admission to anyone they deem not appropriately dressed for the event.
- Any student or guest not permitted because of dress code must remain accompanied by a chaperone until a resolution has been found.
- Temperatures drop overnight –we recommend bring prepared
 - Retail location will have Grad Nite merchandise to purchase including sweatshirts and hats

GENERAL INFORMATION

- Chaperones may bring in laptops/iPads & backpacks (emergency contacts, medical forms, etc.)
- No lawn/folding chairs are allowed
- Blankets/pillows are welcome
- **We are a cashless park.** We have kiosks in the parks to convert cash to a pre-paid debit card or you can purchase pre-paid visa debit card before our visit anywhere they are sold. We do accept ApplePay, GooglePay and CashApp as well.
- Flash Passes are not available for purchase during this event.

Illnesses/ First Aid:

- State Certified EMT's will be on site to assist anyone needing medical attention.
- The first aid station is located across from Lex Luthor Drop of Doom near the Screampunk District.
- Cooler/bag can be brought with medications needed for students. First Aid has refrigerators and storage available for medications as well. All bags will be searched by park security upon entry into the park.

Students with Special Needs:

- Wheelchairs are available for rent. Wheelchair rentals are located near Guest Relations in Six Flags Plaza.
- Six Flags' Attraction Access Program is designed to accommodate guests with disabilities or certain other qualifying impairments so they may participate in the enjoyment of our Parks.

- For any student requiring assistance, please list this in the Special Exceptions section on the chaperone form.

For more information on how to obtain an Attraction Access Pass see below or visit the above website:

To receive an Attraction Access Pass you must have a note from a doctor. You will only need this note the first time you request an Attraction Access Pass. Your doctor should include the following information:

- Doctor's name
- Address of the doctor's practice (Printed stationary is OK as long as it includes the Doctor's medical ID number)
- Phone number of doctor's practice (Printed stationary is OK as long as it includes the Doctor's medical ID number)
- Name of person requesting the Attraction Access Pass
- Statement indicating the guest has a disability or other qualifying impairment under the Americans with Disabilities Act (ADA) and/or applicable state law that prevents the guest from waiting in a standard queue.
- Valid time period of disability (permanent or, if temporary, the valid time period the Pass is needed for)
- Doctor's signature
- **The note must NOT describe or indicate the nature of the disability.**

We strongly urge this is completed before visiting the park, you can bring your note to Guest Relations just inside the front gate of the park. A photo identification must be presented at the time of issuance. For children under the age of 16, a student photo ID will be acceptable. You will only need to present your doctor's note the first time you visit a U.S. Six Flags theme park.
